Crane CU has retained the existing Hulman Field staff, along with the branch location at Hulman Field Air National Guard Base in Terre Haute, IN.

Kevin Sparks, President/CEO of Crane CU, commented, "We look forward to collaborating with the Hulman Field team to expand on their existing member relationships. This partnership is an opportunity to serve our collective membership in greater ways, particularly in the Terre Haute and Wabash Valley areas."

With this merger, Crane CU will have over \$960 million in assets, more than 65,000 members and 20 branch locations throughout Central and Southern Indiana.

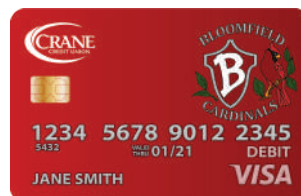

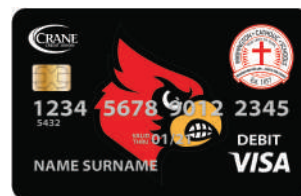

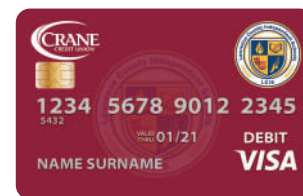
